Breaches in OSHA's Lock-out Tag-out (LOTO) standard cause 50,000 injuries and 120 fatalities annually. LOTO is consistently in the top 5 for OSHA's citations, nearly doubling in the last five years. The Safety Council's Lock-out Tag-out program meets all of OSHA's training requirements. **Note: for all authorized employees this training is required at time of hire and each year thereafter.**
